Privacy Statement Regarding Customer and Online Visitor Information

This Privacy Statement Regarding Customer and Online User Information ("Privacy Statement") applies to ACH MedicoLegal ("ACH MedicoLegal") This Privacy Statement also does not apply to the websites of our Business Partners (as defined below) or to any other third parties, even if their websites are linked to our website. We recommend you review the privacy statements of the other parties with which you interact.

This Privacy Statement governs Personal Information we collect from our customers and from our website and other online visitors ("you" or "your"), as well as information we automatically collect from your online visits (e.g. data collected via cookies). Please refer to your warranty statements and ACH MedicoLegal 's Return Policy for policies that apply to information contained on hard drives returned to ACH MedicoLegal.

For the purposes of this Privacy Statement, "Business Partner" means any subcontractor, vendor or other entity with whom we have an ongoing business relationship to provide products, services or information. "Personal Information" means information that may directly or indirectly identify you, such as your name, telephone number, email address, Internet Protocol ("IP") address and location.

Information We Collect

We may ask you to provide Personal Information when you:

Use our websites or applications;

Request quotes, services, support, downloads, trials, whitepapers, training or information;

Place orders for products or services or register for events or webinars;

Create and manage an account;

Participate in surveys, sweepstakes or other promotional activities online or in any other venue;

Provide a testimonial;

Subscribe to newsletters, ACH MedicoLegal programs, marketing and promotional emails or other materials; Interact with us on third party social networks (subject to that third party's terms of use and privacy policies); or Contact us.

Categories of Personal Information we collect may include your name, email address, home address, contact telephone numbers, user IDs and passwords. It may also include work information such as job title and other business or company information. We may also collect demographic information, such as your age, gender, interests, and preferences. Forms that you choose to complete will indicate whether information requested is mandatory or voluntary. If you make a purchase, we may ask for your credit card number and billing information. We may ask for your national identity number and other data to process your credit or financing request.

In order to offer you a more consistent and personalized experience in your interactions with ACH MedicoLegal, information collected through one source may be combined with information ACH MedicoLegal obtains through other sources. This may include information that allows us to identify you across multiple devices through which you access our websites. We may also supplement the information we collect with information obtained from other parties, including our Business Partners and other third parties to create customised profiles about you. Examples of how we may use this information include using your data to help us to improve your experience using our website, to present you with options tailored to your preferences and for targeted advertising purposes as explained below.

Information We Automatically Collect

We may automatically collect usage information about your visits to our websites, including the pages you view, the links and advertisements you click, search terms you enter, and other actions you take in connection with ACH MedicoLegal website and services. We may also collect certain information from the browser you use to come to our website, such as your IP address, device identifier, location data browser type and language, access times, the Uniform Resource Locator (URL) of the website that referred you to our website and the URL to which you browse away from our site if you click on a link on our site.

Information from Third Party Sources

We may obtain information about you from third party sources such as public databases, our Business Partners, joint marketing partners, social media platforms, and from other third parties. Examples of the information we may receive from other sources include; page-view information from some business partners with which we operate co-branded services or joint offerings, and credit history information from credit bureaus. We may use the information to better understand you to enhance our ability to provide relevant marketing, products and services to you and to help prevent and detect fraud.

How We Use Personal Information

ACH MedicoLegal may use your Personal Information to

Deliver the products, solutions, services and support or carry out the transactions you have requested;

Send communications to you, including information about product safety, your transaction status including notifications about products in your cart and order confirmations, specific ACH MedicoLegal programs in which you have chosen to participate, products, solutions and services available from ACH MedicoLegal, events, promotional offers and surveys;

Facilitate your use of our website, online ACH MedicoLegal chat forums, including ACH MedicoLegal newsgroups and blogs;

Offer Live Chat assistance to respond to your online inquiries;

Facilitate communications from ACH MedicoLegal Business Partners;

Customize, analyse and improve our products, solutions, services (including the content and advertisements on our website to identify usage trends or determine the effectiveness of our marketing campaigns), technologies, communications and relationship with you;

Better understand our customers and online users, including profiling based on interests and interactions with our site;

Personalize content and implement your preferences;

Enforce our conditions of sale, website terms and separate contracts (if applicable) with you;

Prevent fraud and other prohibited or illegal activities;

Protect the security or integrity of our websites, our businesses, and our products or services; or

Perform other functions or serve other purposes, as disclosed to you at the point of collection, or as required or permitted by law.

Legal Basis of Processing

Our legal basis for collecting and using your Personal Information as described in this Privacy Statement will depend on the Personal Information concerned and the specific context in which we collect it. In general, we collect and process your Personal Information on one or more of the following bases:

Your consent, for example where we have obtained your consent to process your personal data for certain activities (such as the use of cookies for online tracking and analysis). You are free to withdraw your consent at any time by contacting info@medicolegal.com. If you withdraw your consent, it will not affect the lawfulness of any processing based on your consent before you withdrew it. Where applicable, we may ask for your consent to processing at the point where you provide your Personal Information.

For compliance with ACH MedicoLegal 's legal obligations where other laws require the processing of your personal information (for example, health and safety, taxation and anti-money laundering laws) or where we need your personal information to protect your vital interests or those of another person.

ACH MedicoLegal 's (and its Business Partners') legitimate interests which include the provision of this website and/or relevant products and services, and/or the carrying out of marketing and profiling activities, provided always that our legitimate interests are not outweighed by any prejudice or harm your rights and freedoms.

Retention of Your Data

We will retain your Personal Information as necessary in connection with the purposes described in this Privacy Statement, for as long as your account is active, and in accordance with ACH MedicoLegal's retention policies and applicable law.

How We May Share Your Personal Information

We may share your Personal Information with ACH MedicoLegal or Business Partners for the purposes described in this Privacy Statement, including (without limitation) to carry out transactions you request, or to make our business (or that of our subsidiaries) more responsive to your needs. Our subsidiaries and/or Business Partners may contact you with information about ACH MedicoLegal, and ACH MedicoLegal -branded products, services or offers. We will only share your Personal Information with ACH MedicoLegal and Business Partners who agree to protect your Personal Information and use it solely for the purposes specified by ACH MedicoLegal.

We may disclose your Personal Information for any purpose with your consent.

We may also disclose your Personal Information in connection with law enforcement, fraud prevention or other legal action; as required by law or regulation; if ACH MedicoLegal (or a part of ACH MedicoLegal) is sold or merges with another company; or if ACH MedicoLegal reasonably believes it is necessary to protect ACH MedicoLegal, its customers or the public.

Except as described above, we will not disclose your Personal Information to third parties for their own marketing purposes without your consent.

Your EU Data Protection Rights

Where the processing of your Personal Information is subject to EU data protection laws, you have the following data subject rights. Please note that these rights are not absolute and in certain cases are subject to conditions as specified in applicable law:

Access: you have the right to request information about how we process your Personal Information and to obtain a copy of that Personal Information.

Rectification: you have the right to request the rectification of inaccurate Personal Information about you and for any incomplete Personal Information about you to be completed.

Objection: you have the right to object to the processing of your Personal Information, which is based on our legitimate interests (as described above).

Erasure: you have the right to request the erasure of your Personal Information (subject to certain conditions).

Automated decision-making: you have the right not to have a decision made about you that is based solely on automated processing if that decision produces legal or similarly significant effects concerning you.

Restriction: you have the right to ask us to restrict our processing of your Personal Information, so that we no longer process that information until the restriction is lifted.

Portability: you have the right to receive your Personal Information, which you have provided to us, in a structured, commonly used and machine-readable format and to have that information transmitted to another organization in certain circumstances.

In addition to the above, you have the right to lodge a complaint with a supervisory authority if you consider that our processing of your Personal Information infringes applicable data protection law.

If you have any questions about the type of Personal Information we hold about you or if you wish to request deletion or correction of Personal Information we hold about you, or exercise any other data subject right, please send a written request to info@medicolegal.com or to the postal address provided at the bottom of this Privacy Statement. While we will make reasonable efforts to accommodate your request, we reserve the right to reject such access requests or to impose restrictions or requirements upon such requests if required or permitted by applicable law.

Selecting Your Communication Preferences, Opting Out of Marketing and the Creation of Customised Profiles about You

You may choose to receive or not receive marketing communications from ACH MedicoLegal by indicating your preferences. Opportunities to select your preferences include the following:

Any marketing by ACH MedicoLegal, or any third parties on behalf of ACH MedicoLegal, will be conducted in accordance with applicable laws and include (where applicable) methods to allow you to express your preferences (including the possibility of being removed from our advertising and marketing lists as set out above).

Please allow up to 10 business days for your email preferences to take effect. As some promotions, such as direct mail catalogues, are developed in advance, you may sometimes receive marketing communications after we receive your preference request. If you opt out of receiving marketing communications, we may still communicate with you in connection with transactions you request and/or other matters.

How We Secure Your Personal Information

ACH MedicoLegal takes all reasonable steps to protect your Personal Information from misuse, interference and loss, as well as unauthorized access, modification or disclosure. The ways we do this include:

Having in place technical and organizational measures designed to ensure the ongoing integrity, availability and resilience of processing systems and services;

Limiting physical access to our premises;

Limiting access to the information we collect about you;

Ensuring that we and our Business Partners have appropriate security safeguards to keep Personal Information secure; and

Where required by law, destroying or de-identifying Personal Information.

We encourage you to keep any passwords you use confidential and to be careful to avoid "phishing" scams where someone may send you an email that appears to be from ACH MedicoLegal asking for your personal information. ACH MedicoLegal will not request your ID or password through email.

Collection and Use of Children's Personal Information

ACH MedicoLegal takes children's privacy seriously. We do not knowingly collect personal information from children through our websites. If you are a child as understood by laws of your country, please do not submit any Personal Information through our websites without the express consent and participation of a parent or guardian.

Cookies and Similar Technologies

How We and Our Partners Use Cookies

ACH MedicoLegal websites use ACH MedicoLegal and third-party "cookies" to enable you to sign in to our services and to help personalize your online experience. These technologies and the information collected about you may be used to track your activity across multiple devices. Where appropriate, we use cookies to store your preferences and other information on your computer in order to save you time by eliminating the need to enter the same information repeatedly.

A cookie is a piece of text that is placed on your computer's hard drive. Depending on the settings you have selected, your browser adds the text to your device as a small file. Many browsers are set to accept cookies by default. You can accept or decline cookies as you prefer. The Help portion of your web browser, most likely found on the toolbar, typically tells you how to prevent your browser from accepting new cookies, how to have the browser notify you when you receive a new cookie, or how to disable cookies altogether.

Cookies allow you to take advantage of some of ACH MedicoLegal 's essential features. If you choose to decline cookies, you may not be able to sign in or use other interactive features of ACH MedicoLegal websites and services that depend on cookies.

Targeted Display Advertising by ACH MedicoLegal and Others

ACH MedicoLegal also works with advertising and personalization Business Partners to use cookies, and Internet browsing to help us display personalized content and appropriate advertising during your visits to mobile applications, ACH MedicoLegal .com and other websites. For example, if you view a product on the ACH MedicoLegal website, you may see offers for similar products on other websites you visit. Cookies placed by these Business Partners also assist us with measuring the performance of our advertising campaigns and with identifying the pages you view, the links and ads you click on, other actions you take on those web pages, and the site from which you came before arriving at a web page. These cookies can be effective whether you are on ACH MedicoLegal .com or another website. If you opt out of receiving targeted display advertising, the data associated with these cookies will not be used.

Targeted Email Marketing by ACH MedicoLegal

Some marketing you receive, including email marketing, may also be personalized based on your visits to ACHMedicoLegal.com and your browsing and purchase history. In addition, when you click on some links in email marketing you receive, our email service provider may place a cookie on your browser. This type of cookie would be linked to your email address or IP address and used to gather information about the products and services you view on ACHMedicoLegal.com. Information gathered may be used to personalize and customize future email marketing messages you receive. You may opt out of this use by clicking on the unsubscribe link provided in every personalized email marketing message you receive.

How We and Our Partners Use Web Beacons, Pixel Tags and Tracking Technology

ACH MedicoLegal or its Business Partners may use web beacons on our websites, in our email messages, in our advertisements on other websites, or in our advertisements in others' email messages. Similarly, third parties whose content or advertisements appear at ACH MedicoLegal .com, or whose email messages ACH MedicoLegal.com sends to our users, may also place web beacons in their advertisements or email messages for the purposes of measuring the effectiveness of the content, advertisements or email messages.

A web beacon is an electronic image that can be used to recognize a cookie on your computer when you view a web page or email message. Web beacons help us measure the effectiveness of our website and our advertising in various ways. For example, web beacons may count the number of individuals who visit our website from a particular advertisement or who make a purchase from our website after viewing a particular advertisement or they may tell us when a web page is viewed and provide a description of the page where the web beacon is placed. Web beacons may also measure the effectiveness of our email campaigns, by counting the number of individuals who open or act upon an email message, determining when an email message is opened and determining how many times an email message is forwarded. Subject to local laws, we may combine the information that we collect through web beacons with other Personal Information we have collected from you.

We may allow some of our Business Partners to compile individual or aggregated statistics from the use of web beacons on ACHMedicoLegal.com by ACH MedicoLegal, its agents or others, to determine the effectiveness of online marketing and to develop statistics on how often clicking on an advertisement results in a purchase or other action on the advertiser's site. Aggregate information may include demographic and usage information. No Personal Information about you is shared with Business Partners for this research.

You can make some web beacons unusable by rejecting cookies in your web browser as described in the **How We and Our Partners Use Cookies** section above.

When you visit our websites or view one of our email messages, we may use pixel tags (also called "clear" gifs), tracking links and/or similar technology to note some of the pages you visit on our websites. We may also use pixel tags to determine what types of email your browser supports. We may use the information collected through web beacons, pixel tags, tracking links and similar technology in combination with your Personal Information to personalize your experience on ACH MedicoLegal.com and to provide you with more useful and relevant advertisements.

Social Media Features

Our website includes social media features, including Facebook "Like" button and Twitter "Follow" button. These features may collect your IP address, which page you are visiting on our site, and may set a cookie to enable the feature to function properly. Social media features are either hosted by a third party or hosted directly on our Site. Your interactions with these features are governed by the privacy policy of the company providing them.

Changes to This Privacy Statement

We will occasionally update this Privacy Statement. If we make changes to this Privacy Statement or make any material changes to how we use your Personal Information, we will revise this Privacy Statement to reflect such changes and revise this Privacy Statement's effective date, included at the end of this section. We encourage you to periodically review this Privacy Statement to be informed of how we are using and protecting your Personal Information.
